# **System Liaison's Report**

Started at 8:34 pm. System Liaison Larson reported on the status of the WARP-1 database migration/system upgrade project ongoing with Inventive since 6/15/2021.

A common question about the project is, "why can't we get an absolute date that the project will be finished?" Larson explained that once tickets are pushed to staging for ASCA to test, bugs are sometimes found and need to be sent back to Inventive to fix. That starts the staging and testing process over again. We had planned to deploy the final tickets and retire ADMS on October 20, but we found some bugs and it has been delayed until October 25. The new computers will be installed at the Business Office on October 26 and the staff will begin working with the new system immediately.

Inventive is currently working on the member portal. The first part of this will be the first-time user login. Each user will need to read the privacy policy and data collection policy. Users can link their current account to their new membership account. There can be no duplicate email addresses – each member must have a unique email address associated with their account. The first use of an email address will be assigned to that account – additional requests to use that email address will be flagged and the user will need to use a different email address. There will also be an authentication process with a code sent via text or email to the phone number or email address on file.

Testing from ASCA's team of subject matter experts has been delayed due to the Nationals. Besides testing functionality, the team will also need to test the workflow. The Webmaster will be creating training videos and an FAQ to help members with the new portal.

Project Lead Maarten Walter has been working on creating SQL queries for ASCA. He has almost completed the stockdog standings, which will now be updated on the website weekly. He is also working on the Supreme Conformation Champion standings and the Business Office should be able to start issuing certificates for this program soon.

Gann asked what is left in the portal that still needs to be completed. Larson has shared this information via email. She thinks the ASCA team can finish testing around Thanksgiving.

## **Abandonment of Kennel Name**

Started at 8:40 pm. The Assistant Office Manager created a form for a member to abandon their kennel name and Director Roberts presented a motion to approve the abandonment process. She does not anticipate that the form will be used very often, but it does free up a kennel name to be used by someone else when it happens.

Gerken wondered if the kennel has accumulated Hall of Fame points will they transfer to the new name? Roberts explained that the computer system tracks the breeder and not the kennel name, so the points will remain with the breeder regardless of the kennel name.

Gann asked if the Office Manager had been consulted about this. Gann had been in this situation (moving from one kennel name to another) and was told by the Office Manager that points would not transfer and that he would need to start over with the new kennel name. Roberts noted that it is more complicated with co-owned kennels, but that the points should count for every breeder.

## Site for 2026 Nationals

Started at 8:51 pm. Director Creelman has requested the Board consider holding the 2026 Nationals in Bakersfield, California. She provided several reasons such as the affordability of the facility, historically high entries at this location, the high population of Australian Shepherds and ASCA members on the west coast, great food vendors, and the overall profitability of events held there. She also said that, despite some safety concerns about the surrounding area, there have never been any issues at the fairgrounds. Creelman thinks we should go to Bakersfield in 2026 while we are still researching suitable sites for future events since we know that it works for ASCA. While finding an eastern site is important, she noted that there are not as many Aussies and Aussie owners on the east coast and they don't tend to travel as far, unlike exhibitors from California who typically attend regardless of the location.

McCabe agreed that Bakersfield may be the most economically feasible facility to hold the Nationals and that the west coast has a high number of ASCA competitors. She also pointed out that the Nationals hasn't been east of the Mississippi River since it was in Tennessee in 2015 and before that, in Wisconsin in 2011 and in New Jersey in 2007. She thought it should be fairly spread around the United States, so all members have the opportunity to attend at some point.

McCabe asked what the Board's timeframe for a decision was. Typically, the Nationals site is chosen at least three years in advance so we can secure the dates needed and put the host committee together.

Gerken thought we should be seriously considering sites east of the Mississippi River but need to make sure they are suitable for ASCA's needs. She thought that we may want to change the timing of Nationals to not include two weekends since that presents difficulty in finding available dates at these sites. She shared concerns about the safety of the Bakersfield site due to its location. She also thought we should be considering locations with nearby tourist attractions

since many members use the Nationals as their vacation time. She thinks the Board should use the next year to compare site costs and information before deciding on a site for 2026.

Larson did not think the Board should decide on this tonight. The Board should give the Nationals Advisory Committee more time to investigate places east of the Mississippi River. She was not opposed to going to Bakersfield but did not think the decision should be rushed. She noted that any Board member can reach out to a facility they think would be suitable to find out the availability of dates and price range, then provide that information to the Nationals Advisory Committee for a more in-depth look.

Wesen said that she is currently researching facilities along with the Nationals Advisory Committee. She said the range of dates needed is often an issue when finding a site. There are possibilities in the east, but we need to make sure the logistics work. She thought ASCA could move the Nationals days from Friday-Saturday to Wednesday-Thursday or something like that to avoid needing two weekends. She also shared concerns about the safety of the Bakersfield site and the lack of good accommodations for agility and conformation. She asked if there was another facility in California that is in a safer location.

Roberts talked about the need for the Board to determine their plans and goals for the Nationals and locations. Does ASCA want to stay in one place or rotate between several sites? Until the Board determines that, no decisions should be made about which site we are going to next. She acknowledged that we can't make everyone happy, but we can try to make it as equitable as possible.

Gann agreed with Roberts that the Board must decide what the parameters are and relay that information to the Nationals Advisory Committee, along with what we are willing to change. Some of the east coast sites may be out of ASCA's price range, but we still need to be investigating them for our members. He thought this should be a topic for the Board's 2023 Spring Meeting.

Byrne thought it was a good idea to set goals before deciding on a site. She thinks the Nationals Advisory Committee is spinning its wheels researching sites without any parameters. She thought it was too early to commit to returning to Bakersfield at this time. She was also concerned about the safety of the Bakersfield location and the suitability of the agility fields.

Sims agreed about the safety concerns surrounding the Bakersfield site. She also agreed that the Board needs to set parameters and decide on the direction we want to go with the Nationals. There is a lot of work that goes into researching sites for our use and it shouldn't be done randomly or without an end goal so our resources are put to better use.

Busquets had previously mentioned that the Board will need to decide whether to go back to the rotation or not very soon and then conduct the work moving forward based on that decision. Sometimes the Board gets stuck waiting for the Nationals Advisory Committee to make a recommendation, but in this case, the Board needs to provide them with more direction and clear goals for the Nationals. That decision should be made during the Board's 2023 Spring Meeting so we have time to consider all the feedback we may receive. At this point, the Nationals Advisory Committee needs to provide the Board and membership with a report on which sites have been investigated and why they are or are not suitable for ASCA's needs. The membership needs to know why certain regions do not have as many opportunities to host the Nationals. The Board will also need updated costs for the Bakersfield site to compare to the others.

Larson made sure to thank outgoing Director Jean Roberts for her many years of hard work and service to ASCA. Her last meeting will be during the Nationals.

President Busquets thanked all the Directors for their work this month and the members listening. Safe travels to everyone going to Nationals.

The meeting was adjourned at 9:23 pm. (Motioned by Larson, Seconded by Roberts).

## **Section 2.8 Not for Breeding Rules**

- 1. The breeder has the option of checking the "Not for Breeding" box on the Individual Registration Application.
- 2. If this box is checked, the Registry Office will issue a Registration Certificate in a different color from the regular Registration Certificate, and it will be stamped "NOT FOR BREEDING."
- 3. The dog's registration number will have the prefix "N." No Litter Registration Application submitted using an "N" prefix for the sire or dam will be processed.
- 4. The Not for Breeding restriction may be rescinded by the litter owner at the litter owner's option. The litter owner must request the Not for Breeding Release form from the Business Office. It must be signed and notarized by all litter owners/co-owners.
- 5. A dog with the "N" prefix may compete for titles in all ASCA-sanctioned events but no litters from this animal will be eligible for registration.

## **Proposed Wording:**

## **Section 2.8 Not for Breeding Rules**

- 1. The breeder has the option of checking the "Not for Breeding" box on the Individual Registration Application.
- 2. If this box is checked, the Registry Office will issue a Registration Certificate in a different color from the regular Registration Certificate and it will be stamped "NOT FOR BREEDING."
- 3. The dog's registration number will have the prefix "N." No Litter Registration Application submitted using an "N" prefix for the sire or dam will be processed.
- 4. The Not for Breeding restriction may be rescinded by the litter owner at the litter owner's option. The Not for Breeding Release form must be signed and notarized by the primary litter owner unless the dog is reverting back to ownership by one or all of the litter owners. In such a case, the release form must be signed by the litter owner taking ownership of the animal but does not need to be notarized.

5. A dog with the "N" prefix may compete for titles in all ASCA-sanctioned events but no litters from this animal will be eligible for registration.

<u>Comments/Rationale</u>: It came to my attention that a breeder/litter owner took back ownership of a dog that they produced. When they went to release the NFB on said dog, ASCA rules required notarizing the release. It seemed like an unnecessary hoop to jump through when the breeder becomes the owner of the dog. The Assistant Manager, the former Registrar, assisted with this motion.

## **JR.22.05 National Specialty Junior Entries**

Comment from Director Gerken: I feel this is the least we can do to support our performance junior exhibitors. I would have liked to see the junior committee recommend ASCA step up similar to the affiliate clubs and provide a junior exhibitor entry at a reduced rate. Very few juniors compete in the performance events, the financial burden on ASCA is nil. It is embarrassing the lack of support ASCA gives to the juniors in performance venues. Our mission statement reads "ASCA is dedicated to ...promoting the Australian Shepherd as an intelligent working dog". Juniors are the future of ASCA. Performance events require greater preparation and additional financial commitment in the way of equipment, coaching, and facilities. ASCA needs to encourage the performance venues to junior handlers equally as much as they support the conformation venue.

**Comment from Director Wesen**: It didn't go far enough to compare with affiliates compensation to Juniors. Looking forward to more programs from Juniors.

Motion by Liaison McCabe to approve the following recommendation from the Junior Committee.

<u>Committee Recommendation</u>: Motion by Andrea Bair to add a new Section 6.9 to the National Specialty Rulebook. Seconded by Alexi Staples.

Results of Committee Vote: Approved: 8. Disapproved: 1. Abstained: None. Non-Voting: 4.

**Dissent from Nicole Fischer**: Discounting entry fees for performance events at Nationals for Junior Handlers is only being seen by affiliate clubs hosting pre-trials. The bulk of the weight to encourage participation is being left to these clubs. They should be applauded for their generosity. One free event isn't comparable to what affiliate clubs are offering throughout the year and at the Nationals pre-trial for juniors who compete in performance.

## **Proposed Wording:**

6.9 Junior Titling Entry Fee

All Juniors competing at the National Specialty in events not included in Section 6.8 may receive one free National Specialty entry. The Junior will decide which program (agility, conformation, obedience, rally, or stock) they would like to use the free entry on and notate on their entry form and submission form. The Junior must own or co-own the dog in accordance with Junior Rule Section 1.8 for the required sixty days preceding the opening date for entries to qualify for the free entry. The junior must also exhibit the dog themselves. Juniors may enter additional classes at the regular rates published in the Nationals Premium.
